Introduction

Criteria to endorse the Global Mangrove Alliance

- *Undertake work in collaboration with Alliance Members on mangrove activities to ensure cost-effectiveness and avoid duplication of efforts.*
- *Provide sustained support of the planning and implementation of the GMA's overall strategy*
- *Provide funding, expertise or other resources to support the programmatic work of the GMA.*
- *Encourage other government, inter-governmental organization or non-governmental organization, including private sector entities, to become a GMA Member or Endorser*
